The meeting was called to order at 7:00pm by President Mike Winter. Mike Winter gave devotions.

- Secretary's minutes from the January meeting: Motion to approve by Mike Loos, seconded by Matt Solon. Motion carried.
- Financial Secretary report: Motion to approve by Matt Solon, seconded by Greg Steensland. Motion carried.
- Treasurer's report: Motion to approve by Matt Solon, seconded by Nick Rickard. Motion carried.
- Capital Fund report: Motion to approve by Char Les Kemmish, seconded by Greg Steensland. Motion carried.
- Memorial Fund report: Motion to approve Mike Hipnar, seconded by Nick Rickard. Motion carried.

Pastor Cara gave her monthly written report. She highlighted the Synod Assembly dates are April 9 -10. Shelby Rickard has agreed to be a delegate. Motion to approve by Alan Ellis, seconded by Greg Steensland. Motion carried. Motion by Char Les Kemmish to approve \$110 for each Pastor Cara and Shelby Rickard (totaling \$220) to attend Synod Assembly, seconded by Alan Ellis. Motion carried. Pastor Cara will register them both.

Old Business: None

#### **New Business:**

- Elizabeth Miller Estate is now \$327,903.07. Alan Ellis will ask Property Committee to provide a list of future foreseen property expenses. Matt Solon mentioned that Rick Stone is reviewing whether to put part of the Estate in a CD with dividends.
- President Mike Winter received a request from Michaela Lewis for video equipment for live streaming church services totaling \$1,565.65 plus changing StreamYard to a

yearly subscription for a \$60 discount (totaling \$240/year). Motion to approve by Greg Steensland, seconded by Alan Ellis. After discussion, motion was withdrawn. Mike Hipnar suggest we find a long term plan for live streaming. Pastor Cara will talk to St. John Lutheran Church Pastor and see if their guy could provide some input.

- Pastor Cara requested days off for March 8-11 (Monday-Thursday). Motion to approve by Chris Reed, seconded by Mike Hipnar. Motion carried.
- President Mike Winter presented a request from the Boy Scouts to hold a drive up pancake breakfast at church on Saturday, March 13 from 9-11am. Motion to approve by Mike Loos, seconded by Shelby Rickard. Motion carried.
- Nick Rickard presented the church buying a 15 person Van. Nick will contact dealers to get a general idea of costs for new vs used. Mike Winter will contact Edwards Nissan. Alan Ellis suggested AWD vehicle.
- Nick Rickard asked if the church was ready to relax COVID restrictions since the State of lowa has relaxed theirs. President Mike Winter recommended we keep as is for the next few months and review again in a few months.
- Chris Reed presented to set up a committee to look into Solar Panels. She mentioned that Cindy Richards was attending a webinar regarding the matter. Alan Ellis mentioned to look into GEO Thermal, he will call to get more information. No committee was formed at this time.
- Chris Reed presented adding the church to the weekly church listing/activity in The Daily Nonpareil if free. Pastor Cara will talk to Michaela Lewis to get the church added. Alan Ellis suggested our Welcoming Statement too.

Next meeting is March 15 with Pastor Cara doing devotions.

Motion to adjourn the meeting was made by Greg Steensland, seconded by Shelby Rickard. Motion carried. The meeting was adjourned by President Mike Winter at 7:45pm.

#### **Council Minutes for March 13, 2021**

Guests: Oscar Over, Rick Stone, Richard Reed (from the Finance Committee)

The meeting was called to order at 7:00pm by President Mike Winter. Pastor Cara gave devotions.

- Finance Committee Report: Oscar Over, Rick Stone and Richard Reed reported the committee decided to invest some of \$404,206.09 Elizabeth Miller Estate instead of earning no interest in the checking account. The committee committed to two \$100,000 to the ELCA Mission Fund for 3 years with 1.5% interest. If the church does an early withdrawal, a penalty of 1.5% will be charged. The committee also discussed plans for two additional CDs with Veridian Credit Union for \$50,000 for 7 months with 0.75% interested and another \$50,000 for 21 months with 0.90%. The committee recommended to keep \$50,000 liquidated for an emergency fund. The committee will hold off on the Veridian Credit Union CDs until the church council discusses further.
- Secretary's minutes from the February meeting: Add member absent: Joel Hauschild. Motion to approve by Nick Rickard, seconded by Alan Ellis. Motion carried.
- Financial Secretary report: Motion to approve by Chris Reed, seconded by Alan Ellis.
- Motion carried.
- Treasurer's report: Motion to approve by Alan Ellis, seconded by Nick Rickard.
- Motion carried.
- Capital Fund report: Motion to approve by Alan Ellis, seconded by Shelby Rickard.
- Motion carried, included approval of two \$100,000 CDs to ELCA Mission Fund.
- Memorial Fund report: Motion to approve Chris Reed, seconded by Char Les
- Kemmish. Motion carried.

Pastor Cara gave her monthly written report. She highlighted the Boy Scouts will be rescheduling their pancake breakfast sometime in April. They will no longer be meeting after the end of the year. If anyone is still needing to get their COVID vaccine and is finding it difficult navigating the system to get an appointment, she is will to help. Pastor also talked to Michaela Lewis regarding the Church News section of The Daily Nonpareil. We've been in the last two weeks, Michaela will continue to submit weekly.

#### Old Business:

- Mike Winter received two proposals for a van purchase. First, for a new 12 person van \$39,331 and second for a used 12 person 16,000 miles for \$29,500. Also received an estimated proposal of \$1,800 for insurance per month. Mike Hipnar said The Band would use the van 4 times a year. After further discussion, no motion was made.
- Alan Ellis did research on solar panels, this is not a good area for them. Also, GeoThermal would be better in our climate, estimated cost \$25,000-\$35,000 and the return is average 3 years. Mike Winter asked Alan if GeoThermal would replace some of the furnaces. The answer was No.

#### **New Business:**

- President Mike Winter asked each council member to circle their top 3 priorities for potential spending of Elizabeth Miller bequest. Results will be distributed by next meeting.
- President Mike Winter made a recommendation to nominate Connie Edson to join the church council for a 2 year term. Motion to approve by Alan Ellis, seconded by Mike Hipnar.
- Council discussed some options to invest money for improvements for the church. One, upgrading the electronic equipment to stream online. Pastor Cara will contact Midwest Sound & Lighting to do full evaluation. Second, Alan Ellis remembered the bid on upgrading the current restrooms and adding an un-sex handicap bathroom estimated costs of \$60,000 from the day care start up project.

Third, outside display sign was discussed. Alan Ellis said he reviewed traffic study and North Broadway is a high volume traffic location. Fourth, Mike Hipnar researched Robot vacuums estimating around \$400/each. Alan Ellis added they would need to be more durable, have several of them and self-empty. Fifth, Property Committee provided a document of capital repairs or replacements we should anticipate and prepare for, including air conditioners, furnaces, parking and roofs. Once bids are received, more discussion will continue.

President Mike Winter reminded the council of our bylaws "may incur obligations more than \$2,500 in excess of anticipated receipts only after approval by a Congregational Meeting".

Next meeting is April 19 with Mike Hipnar doing devotions.

Motion to adjourn the meeting was made by Shelby Rickard, seconded by Alan Ellis. Motion carried. The meeting was adjourned by President Mike Winter at 8:20pm.

## National Child Abuse Prevention Month



According to the most recent Iowa Department of Human Services data, 9,532 Iowa LUTHERAN SERVICES IN IOWA children were subject to abuse or neglect. The most common forms of abuse included people denial of critical care, physical injury, exposure to illegal drugs or dangerous substance, and sexual abuse.

#### **Empowering Iowa Families**

Gaylene was overwhelmed raising three young boys. Finances were strained and she and her partner, José, worked hard to make ends meet. Suddenly, well into her second trimester, Gaylene learned she was pregnant with her daughter, Julieanna. Left with less time to prepare her home for a fourth child, Gaylene was stressed at the thought of welcoming a little girl into a house with three energetic older brothers. And once Julieanna was born, Gaylene began experiencpostpartum depression.

Gaylene enrolled in LSI Early Childhood Services for help, and she and José began meeting with their LSI worker, Kellie. She provided the family with ageappropriate ideas and developmental activities for the

kids, and served as a shoulder to lean on whenever Gaylene or José needed guidance or advice. Gaylene recently graduated from college with a degree in early childhood education, and her family is thriving. Gaylene also graduated out of LSI services last year. The family still keeps in touch with Kellie, and Gaylene says she will forever be grateful for the support she received when times were difficult.

"We got so used to Kellie coming to our home for five years, it's going to be different. But now I know where to turn and how to help my family down the road," Gaylene says. "I feel like Kellie and LSI actually care about people and parents."


When we are tested and wrestle alone,
Famished for bread when the world offers stone,
Nourish us, God, by your word and your way,
Food that sustains us by night and by day.
When in the desert we cry for relief,
Pleading for paths marked by certain belief,
Lift us to love you beyond sign and test,
Trusting your presence, our only true rest.
When we are tempted to barter our souls,

Trading the truth for the pow'r to control,
Teach us to worship and praise only you,
Seeking your will in the work that we do.
When we have struggled and searched through the

Ruth is an ordained minister in the United Church of Christ. She taught worship and the arts, teaching congregational song, and healing and reconciliation at Garrett-Evangelical Theological Seminary in Evanston, Illinois. Early in her career she updated older hymns using more inclusive language. In addition to writing several collections of poetry (*The Poetry of Grace, Welcome God's Tomorrow, and Circles of Care*) she edited and contributed to *Everflowing Streams-Songs for Worship*. Our ELW contains four of her hymn texts, *Arise, Your Light Has Come!, Wash, O God, Our Songs and Daughters, Remember and Rejoice,* and *In Christ Called to Baptize*. In the new *All Creation Sings* hymnal, there are six of her hymn texts which we will be exploring in the coming year.


